**TRUST DEED OF
COPYPEN FOUNDATION**

This Deed of Public Charitable Trust executed on this day of 6 July, 2021 between **Abu Fahad Siddique** S/o Mahmood Alam, Age 33 years, Resident of Bairanpur(BEWDA), Birahim Pur, Jakhania, Ghazipur, Uttar Pradesh- 275203, hereinafter called the 'Settler' (which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representatives) of the one part,
and

1. **Abu Fahad Siddique** S/o Mahmood Alam, Age 33 years, Resident of Bairanpur (Bewda), Birahim Pur, Jakhania, Ghazipur, Uttar Pradesh - 275203,
2. **Mohd. Asif** S/o Jamaluddin, Age 28 years, Resident of C- 1/22 Raju Park, Gali C-1, Near Sainik Farm, Devli Road, Khanpur, South Delhi, Delhi - 110062,
3. **Mohd. Aquib** S/o Mohd. Asif, Age 22 years, Resident of Bevda, Khetabpur, Ghazipur, Uttar Pradesh - 275203;

hereinafter jointly referred to as 'Trustees' (which expression shall, unless excluded by or repugnant to the context, be deemed to include the Trustee or Trustees for the time being of these presents and their successors in office) or members of the other part. The Trustees shall constitute themselves into a "Board of Trustees" also called as "General Body".

Whereas the Settler/founder is desirous of establishing the national level Social Development, Social Welfare and Social Service Non Governmental Organisation as a Trust for public charitable purpose and public welfare purpose objectives creating facilities for the benefit of society at large more specifically for objectives and purposes to Social Development, Social Welfare, Social Awareness, Education, Knowledge and Skill Development, Health, Development and Empowerment of Women, Welfare and Development of Youth, Environment Conservation, Livelihood upliftment, and welfare of needy and financially deprived people people of Society and Sustainable Development.

The "charitable purpose" of Trust is to be defined as according to Clause (15) of Section 2 of Income-tax Act, 1961. And whereas the Trustees have, at the request of the settler, agreed to act as the first Trustees of these presents as testified by their being parties to and executing these presents. And whereas it is necessary to declare the objectives and terms of the public charitable Trust, being constituted under these presents.

Now this indenture witnesseth as follows:

1. That, in order to effectuate his aforesaid desire, the settlor has set apart and handed over to the Trustees, a sum of Rs. 1000/- (Rupees One Thousand only), hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the Trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents, and the Trustees shall hold and stand possessed of the same upon the Trust subject to the powers, provisions, agreements and declarations hereinafter contained.
2. That the name of the Trust shall be '**CopyPen Foundation**' and its principal registered offices shall, for the present, be situate at **C 1/22, Ground Floor, Raju Park, Khanpur, New Delhi - 110062.**

The registered office can be changed by the Board of Trustees according to the applicable laws and rules of present registered area; and as rules, acts and laws required and applicable in the concerned jurisdiction of the required area for the new registration office.

The administrative office of the Trust shall be at Bairanpur (Bewda), Birahim Pur, Jakhania, Ghazipur, Uttar Pradesh – 275203. The administrative office(s) and Branch office(s) can be established at New Delhi, Ghazipur, Delhi, in the States/Union Territories Uttar Pradesh, Haryana and all states and territories of India and/or at any such other place or places in India as the Trustees may decide from time to time. The administrative office(s) can be added and changed by the Board of Trustees as per the applicable laws and rules.

3. That the objectives of this Trust 'CopyPen Foundation' are:

1. To open, found, establish, promote, set-up, run, manage, maintain, assist, finance, acquire, take over, support and/or grant aid or help in the set up, establish, manage, develop, and/or maintain, run, and/or other financial and technical assistance to Schools, Colleges, Institutions, Center and Bodies, and other Educational, Cultural, Medical, Para-medical, Nursing, Health, Diagnosis system, Engineering, Management, Law, Computer and Information Technology, General Education, any Technical and all kind of Educational, Teaching, Learning and Training Institutions, Colleges, Universities, Organisations, Bodies, Authorities for all the education, learning and benefit of learners, career seekers, needy students, needy persons and for general public.
2. To setup, run, undertake and manage Skill Development Programmes, Projects, Schemes and Activities for all kind of Skill and for all status and all kind of needy persons.
3. To setup, run, undertake, manage and develop Skill Development programmes, projects and schemes for People and provide job training to make capable, self employed and to develop and improve job opportunities for for them.
4. To provide online education and training to students and youth for education and career.
5. To provide education and training to students and youth for developing the knowledge, skills and expertisation for education, career and profession.
6. To establish, maintain, run, grant, pay or give scholarship, studentships, stipend, prize, rewards, allowance, loan and other financial assistance or help in cash or kind to deserving students with a view to help them in pursuing their studies.
7. To establish run, establish, operate and manage schools
8. To run, establish and manage residential hostels for Schools and colleges for Students, Scheduled Castes and other backward class students.
9. To provide career guidance and help to students to find suitable jobs and career opportunities.
10. To run and manage Trainings for all kind of Competitive examination for all kind of jobs.
11. To provide Health Care, Medical and Treatment to the society and needy people.
12. To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running Medical, Health and all kind of Hospitals, Charitable Dispensaries, Maternity Homes, Clinics, Child welfare centres, Treatment centres related to Medical and Health System and Practices.
13. To operate ambulances, mobile clinics, mobile check-up centres.
14. To setup, run, support and manage De-addiction programmes, campaigns, centres, clinics, hospitals for persons affected by intoxication, intemperance, addiction and habits of tobacco, alcohol, drugs, narcotic drugs, narcotic and other harmful materials.
15. To work to eradicate the evil of drug addiction.
16. To work and undertake projects to prevent substance abuse, such as Alcohol abuse, drug abuse and other intoxication based abuses created by use of intoxicant substances.
17. To create mass awareness and educate people to stop Cancer and undertake various programmes for prevention of Cancer.
18. To undertake, run and manage Sanitation and Programmes, Schemes, Projects, Activities and works including the projects under Swachh Bharat Mission Projects and Programmes.
19. To promote and develop health and sanitation practices for the overall good of the society.

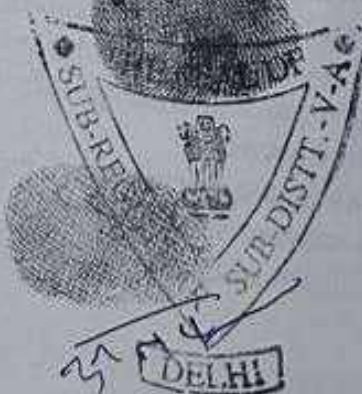

20. To run, undertake and implement programmes and projects through the community participation and development approach to address and resolve the problems of needy and backward communities and people.
21. To conduct fundamental and applied works on socio-economic condition, language, life, culture and heritage of the people.
22. To reach out to homeless underprivileged and street children without any form of support, in order to understand and analyse their life situation and socio-economic needs.
23. To raise awareness on children's rights. To eliminate Trafficking of the children.
24. To establish, setup and manage Child Care Centres, Stay Homes and Orphanages for the poor, orphan and needy children and provide shelter, food and education to them.
25. To protest against exploitation of children and establish centre for their care taking. To work for the eradication of child labour.
26. To undertake, manage and initiate programmes for Empowerment and welfare of Women.
27. To work for the socio-economic upliftment of women.
28. To help and support by Training, Skill Development Programmes and courses to women and needy persons.
29. To undertake programmes and activities for women empowerment and upliftment with the aim to make them self reliant and independent.
30. To provide financial assistance and support by running and managing programmes and projects for improvement of livelihood of women.
31. To run and manage stay homes for widow women and work for their welfare.
32. To work for welfare and development of Divyangjan - People with Disabilities (PwDs).
33. To work for, undertake and run programmes for the welfare, development and empowerment of Physically challenged persons (Divyang)/ People with Disabilities (PwDs), Divyang People with Disabilities (PwDs) and all kind of persons with disabilities.
34. To run and establish Old Age homes.
35. To run and undertake projects and programmes for the welfare of Old Ages people and Senior Citizens.
36. To undertake, implement projects and programmes for agricultural, fisheries development and natural resources management.
37. To undertake, implement projects and programmes for agricultural development and natural resources management.
38. To run and undertake Environment Conservation and Protection programmes and Projects.
39. To run, undertake and manage awareness programmes and Projects for Environment Conservation and Protection.
40. To undertake, manage and run, promote tree plantation projects/ programmes, cleanliness drives, sanitation campaigns, pollution prevention activities.
41. To protect and conserve water, lakes, water bodies, ponds and drinking water resources.
42. To undertake, support, manage and run growing, sheltering and surviving tree plantation projects, programmes, campaigns and activities.
43. To work for and undertake projects and programmes to control global warming.
44. To run and undertake water conservation projects and programmes including conservation and management of water for drinking and irrigation.
45. To run all kinds of projects, programmes and developmental work meant for the all kinds of waste management (e.g. solid waste, liquid waste, municipal, hazardous, biomedical waste etc.).
46. To develop integrated and environmentally organic waste management system that ensures the adequate collection and treatment with sustainable methods with close agricultural activity.
47. To work to control the pollution by the hazardous chemical and other waste materials.
48. To run campaigns drive for clealiness, waste management and clean environment, pollution free environment and remove hazardous conditions of environment.
49. To work for welfare, protection, treatment and facility development of animals.

50. To work for and undertake programmes to save stray and needy animals including cows, dogs and providing them shelter, security, protection and survival facilities.
51. To create awareness to save, protect and conserve wildlife, forests and take necessary action.
52. To manage, undertake and run programmes, projects and activities for poor people for their development and welfare.
53. To Create job placement and employment opportunities by various means for youth and needy people for upliftment of their living standards and improve income generation.
54. To create, generate and support the livelihood generation opportunities and options by marketing, production, participation in income generation options for needy people of society.
55. To create, run, setup various option, opportunities and infrastructures for income generation and livelihood and improvement of living standards of life for various persons of society.
56. To plan and execute an integrated programme on development and implementation of renewable solar energy projects.
57. To establish, promote, run, maintain, assist or help in running destitute homes, orphanages, rehabilitation centres, houses for the Tribals, poor and infirm people, destitute, needy and Below Poverty Line (BPL) persons.
58. To work to control the rapid increasing population which offsets endeavour for development.
59. To work for population control through awareness, Population Education, seminars, meetings and other events and programmes.
60. To run and undertake various programmes including legal actions, lobbying and advocacy on various social issues and work as pressure group.
61. To run programmes for Labourers and work for the welfare of Labour communities.
62. To run, manage and undertake human rights programmes, projects and activities of Human Rights and Social Justice.
63. To undertake programmes and projects with the help of the individuals, groups, institutions, funding agencies, support agencies, Government departments, Government ministries, philanthropies and those who want to support and help for the minority communities, Tribal communities and other backward communities and needy persons and groups of society.
64. To work for social, financial, economical, educational, health and other development of minority communities.
65. To work for the welfare and empowerment of weaker section of the society and for the socio-economic upliftment and empowerment of people of minority community and other backward communities.
66. To empower the minority community by various projects, programmes and activities.
67. To run, undertake and manage programmes for empowerment of minority communities.
68. To undertake and get approval of Government and other schemes for development of minority communities.
69. To run, undertake, operate and manage programmes for upliftment, welfare and development of minority communities.
70. To run, manage, setup, support and undertake microcredit and microfinance programmes, projects and activities for rural development, urban development and social development, so economically poor persons can gain financial and social strength.
71. To work to promote the Micro, Small and Medium Enterprises and Industries and work for the promotion of these sectors.
72. To run, manage, undertake and provide Training and skill development programmes, activities and projects for Micro and Small Scale industry, Home industry (Grih Udhayog), Small industries, small enterprises and for other entrepreneurship.
73. To run, manage, undertake programmes, activities and projects for Khadi, Khadi related and Khadi related products.
74. To establish and operate branches of the Trust at local level, block, district, state and national level for the objectives of the Trust.

75. To establish collaboration and coordination with government, semi-government and public agencies Non Governmental Organisations.
76. To develop and nurture appreciation of Indian traditional Art, Craft and Culture through the educational programmes, cultural orientation programme and outreach activities.
77. To work to conserve, maintain, develop and preserve Culture, Art, Craft, handicrafts, cultural heritage, monuments and other natural and traditional resources and traditions.
78. To grant relief and assistance to the needy victims during disasters, natural calamities such as famine, earth quake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or individuals engaged in such relief work.
79. To co-operate other institutions and organisations which match or aims and objectives, and order to fulfill these aims and objectives to accept the donating of money, land etc.
80. To provide and distribute free medicines, clothes food items etc. to helpless, poor, downtrodden and underprivileged people, backward areas, rural, hilly and tribal areas.
81. To organise exhibitions, workshops, seminars, conferences, demonstrations, display programmes and camps to attain the objects of the Trust.
82. To help poor, exploited and needy people in every respect so as to uplift their lives, including but not limited to medical relief, educational help, housing facilities, legal aid and other support.
83. To work for the welfare and upliftment of the poor, exploited and unprivileged people.
84. To run and organise programmes and projects in sports, health in Yoga and Yoga related schemes.
85. To organise sports tournaments and sports festival at various level and participation at all level championships.
86. To organising Tournaments and competitions at local, district, region, state and national for sports and games to promote the games.
87. To incur any expenditure on any programme relating to the main objects of Trust and any investment thereof which the Trust considers likely to contribute to its main objects.
88. To undertake consumer protection and consumer right programmes, issues and activities.
89. To promote and establish anybody having objects altogether or in part similar to any of the objects set out above and to sponsor or otherwise support activities of any such body insofar as the same shall be incidental or conducive to any of the objectives of the Trust.
90. To do all such other lawful activities as are incidental or conducive to the attainment of the objects. To carry out, encourage and support any act, matter or thing which is or may be incidental or conducive to any of the above objects or which may be conveniently done in connection therewith.

And other objective of charitable purpose, charitable nature and advancement of general public utility as may be defined or interpreted as charitable purpose under the provision of the Income Tax Act, 1961 and other related laws for the time being in force.

The Board of Trustees may amend and modify the objectives and include any other charitable purpose objectives time to time in accordance with the intention of the Trust.

All the objectives and purposes of the Trust shall be of charitable purpose and charitable nature. All the charitable objectives and charitable purposes of the Trust shall be according to Income Tax Act, 1961 and other Laws, Acts, Bye-laws, Rules of Government of India.

Without limiting the generalities of the above mentioned objectives and clauses, to perform or carry out all such acts, deeds or things as may be necessary for the attainment of the main objectives contained herein.

4. The Board of Trustees shall have the power to make and alter or amend the rules and regulations with regard to the better conduct of the affairs of the Trust with the approval of the Board of Trustees as and when necessary.



The Board of Trustees shall have the power to make and alter or amend the rules and regulations with the previous approval of the Commissioner of Income Tax or concerned authority (if required or applicable) having Jurisdiction over the Trust if the Trust is registered with Income Tax Department under Income Tax Act, 1961 for any kind of Tax Exemption; or there is any requirement to change or alter or amend the rules and regulations of the Trust by the authority of Income Tax department as per necessarily applicable rules of the Income Tax Act, 1961.

5. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.

6. That the Trust Fund shall not be applied for any profit purpose and not be applied for any other purpose those defined and specified in Para 3 of the Trust herein above. The Trust Fund shall be applied for charity purpose as specified in Para 3 of the Trust herein above.

7. That the Trustees shall constitute themselves into a "Board of Trustees" of the Trust.

"Board of Trustees" of the Trust shall have all the powers of the Trust including planning, management, execution, implementation, decision making and all powers mentioned in the Indian Trust Act to run, setup, manage, execute and implement the programmes and all work of the Trust. The decision of "Board of Trustees" will be final in all cases, matters and resolutions.

8. That the "Board of Trustees" shall constitute "Executive Committee" or "Governing Body" of the Trust for the planning, management, administration and implementation of the programmes, activities, plans, projects and tasks of the Trust. Board of Trustees can provide and decide designation and official posts of the Trustees in the Executive Committee or Governing Body.

In case of any contravention or conflict arises on any decisions of the "Executive Committee" then the decision(s) of "Board of Trustees" or the authority or authorised person(s) appointed by "Board of Trustees" will be final.

9. Board of Trustees or General body of the Trust may decide management of The Trust. Board of Trustees or General body of the Trust may decide Responsibility, Duties, Powers, Liability and limitations of 'Board of Trustees' or 'General body' itself of the Trust, Member(s)/ Trustee(s) of Board of Trustees or General body of the Trust, 'Executive Committee' of the Trust, Member(s)/ Trustee(s) of Executive Committee of the Trust, Managing Trustee/Managing Director of Trust, President of Executive Committee of the Trust, Secretary of Executive Committee of the Trust, Office bearers of Executive Committee of the Trust and all other committee(s), forum(s), authorised body/bodies, authorised person(s), authorised Executive(s) and authorised member(s).

10. That the Board of Trustees shall have the entire management and control of the property and affairs of the Trust. The Board of Trustees can take decision on the management and control of the property and affairs of the Trust.

11. That the Executive Committee and/or Board of Trustees shall always maintain proper accounts of the Trust, which shall be kept at the administrative office of the Trust or at any other suitable place where the Board of Trustees decides.

12. That the Board of Trustees shall organise at least one general meeting in a year.

13. That without affecting the generalities of powers and functions of the Trustees, to manage and administer the Trust and for the furtherance of the objects the Board of Trustees shall have following powers (Board of Trustees can authorise to implement, deliver, control the powers, functions, responsibility, duties, liability and limitations of authorised body/bodies, authorised person(s), authorised executive(s) and authorised member(s) for all or certain powers and functions): (a) To accept any donation, contribution, grant, aid, support, help or subscription in cash or in kind, from any person(s), body of persons or Trust, support agencies, companies, organisations, funding agencies, Government Ministries and departments, Charity organisations/groups, Associations, Foreign Funding Agencies Funds under Corporate Social Responsibility with or without conditions. (b) To apply the whole or any part of the income of the Trust, or the Trust fund or accumulations thereto, to any one or more of the objects of the Trust, as the Trustees may, in their discretion, deem fit from time to time.

(c) To convert and deal with the Trust property and/or any investments for the time being.
(d) To invest the Trust Fund either in the purpose of purchase or mortgage of immovable property or in other securities and investments, or in deposits with or loans to any company, bank, firm, or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the Trustees. (e) To borrow or raise or secure payments of moneys and also to lend money either with or without security.

(f) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
(g) To let out, demise any immovable property comprised in Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.

(h) To open account in the name of the Trust, Trustees and/or Institutions, Committees run/conducted/operated/managed by the Trust with any Nationalised Bank(s), Public sector Bank(s), Private Bank(s), Co-operative Bank(s), Gramin Bank(s), International Bank(s) or any Bank as authorised Bank(s) from the Reserve Bank of India or other concerned government or legal agencies/authorities, to operate such account and to give instructions to the Bank. Bank account can be opened in the name of the Trust by Trustee/Trustees or by the trustee/member/agent/authority appointed by the Board of Trustees.

(i) Trust can open Bank account in the name of the Trust "CopyPen Foundation". The Trust can open bank accounts anywhere in India, including New Delhi, Delhi, Ghazipur or/and all other cities and towns and in the States including Delhi, Uttar Pradesh, Haryana and in all states of India and/or at any such other place in India as the "Board of Trustees", Authorised body, Authorised person(s) may decide from time to time.

The Trust can open Bank account at the Administrative office of the Trust or at Registered office or/and at other place also, wherever the Board of Trustees may decide to open the account, according to the applicable laws. The Board of Trustees can open bank account anywhere as the Board of Trustees or authorised signatories of the Trust decides by resolution to open the account according to applicable rules of Reserve Bank of India and the applicable laws Government of India.

(j) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.

To appoint constituted attorneys, consultants, or agents and to delegate to such attorneys, consultants or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his/her or their place. To appoint employees and salaried persons, contract persons, support persons for the work and fulfillment of the aims and objects of the Trust.

(k) To appoint or make provision for the appointment of any person (including all or any of the Trustees and committees or administrator or Managing Trustee/Managing Director or otherwise) for the purpose of the administration, management, operation, representation, running, managing/ operating bank account and governance of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to appoint or provide for the appointment to separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit. (l) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust. (m) To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public, and to impose any conditions to any subscription or donation made by them. (n) To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust. (o) To join, co-operate or amalgamate this Trust with other or others having like-minded or allied objects, upon such terms and conditions as the Trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.

(p) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organisations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organisation or Trustees to start maintain, or carry out such charitable objects.

(q) To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things as deemed proper for such purpose without being responsible for any loss occasioned thereby.

(r) To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

(s) To apply to the Government, public, urban, local, municipal, district and other bodies, corporation, companies, organisations, agencies, or persons to accept grant of money and of aid, donations, gifts, and other assistance with a view to promoting objects of Trust.

To discuss and negotiate with the Government Departments, public and other bodies, corporations, companies, organisations, agencies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.

(t) To takeover or amalgamate with any other charitable Trust, society, association, or institution of similar objects.

(u) To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing, organising, or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.

(v) To take over, acquire, manage, control or aid any existing institution or institutions, bodies, associations or associations, and support groups having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.

(w) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorised to amalgamate.

(x) To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the trust, societies, institutions or associations with which this Trust is authorised to amalgamate.

(y) To transfer and hand over the Trust to any other Society, Corporation, Institution, Trust or Organisation on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution, Trust or Organisation with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall become discharged from the Trust hereof relating to Trust Funds so transferred.

(z) The Trust can acquire, undertake and/or share with any other like-minded organisation, society, trust, organisation, agency, non-governmental organisation, institution, authorised body or any group for development, welfare, support, help, sharing and fundraising of this Trust. To take donation on behalf of any non-profitable organization, agency, institution and organisation with their permission.

14. The Board of Trustees may give, deliver or assign the above said powers to Trustee/Trustees, Executive Committee or any committee of the Trustees specifically.

No individual Trustee other than the Managing Authority has the power to act on behalf of the Board of Trustees, except when specifically authorised by resolution or by the Trust Deed. The Trust can appoint the Managing Trustee or Managing Director of the Trust.

15. The Trustees shall be accountable only for such moneys, resources and funds as shall actually come into their hands or possession or ownership, and a Trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other Trustees, nor of any banker or other person with whom the Trust properties or any securities may have been deposited or kept.

16. The Trustees shall not get any salary or profit out of the funds, income and assets of the Trust, but the Trustees may take honorarium from the projects, institutions established, either solely run and managed by the trust or being one of the partner; if, the trustee would render her/his services, skills and capital to the affairs of such projects and programmes.

The Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

17. The number of the Trustees shall not be less than two and there is no limit of maximum Trustees. If the number of the Trustees shall fall below two, the Trustees shall not, except for the purposes of filling any vacancy, act so long number is below the said minimum.

18. The Board of Trustees will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the Board of Trustees considers proper. The Board of Trustees can decide the tenure of the all such Trustees.

19. A person shall cease to be a Trustee either:

(i) if he/she without leave of absence does not attend three consecutive meetings of the Board of Trustees or for one calendar year, whichever is longer, or

(ii) if he/she is requested to resign by 3/4th or as near thereto as possible of the remaining Trustees.

(iii) if a Trustee found guilty of - misconduct or abuse of office, acting dishonestly or fraudulently, misappropriation of Trust funds, moral turpitude, application of trust property to private purpose.

(iv) if a trusty found guilty of misbehaviour or misconduct; can be removed by the Board of Trustees or the Managing Trustee/Managing Director of the Trust. And the decision of the Board of Trustees or the Managing Trustee/Managing Director in this behalf shall be final and binding and shall not be called in question anywhere.


20. A Trustee alone can not execute the Trust alone, specifically in respect of property; nor contravene any of the restrictions contained in the Trust Deed, without decision of the Board of Trustees.

21. A Trustee can not transfer the Trusteeship nor shall he/she delegate his/her power/right to any proxy to cast a vote or attend the meeting of the Board of Trustees, as a Trustee. In case of retirement, resignation, removal or death of a Trustee, the vacant post of Trustee can not be filled by the procedure other than that is specified in Para 19 of the Trust herein above.

22. Every Trustee will be at liberty to resign on giving one month's notice of his/her intention to do so.

23. That the Board of Trustees or the authorised body of the Board of Trustees can form, select and appoint various Associations, Organisations, Councils, Committees, Networks, Forums and Groups under the Trust, comprise of the Trustees, sympathisers, advisors, supports, beneficiaries of the Trust, stakeholders, experts, citizens and other persons.

The following rules and regulations will be applicable for such Associations, Organisations, Councils, Committees, Networks, Forums and Groups formed by Board of Trustees or Authorised body or Authorised Trustee/ Member: (a) The Board of Trustees can provide ordinary/ lifetime/ honorary/ selected/ appointed/ affiliated membership to the beneficiaries, eligible persons, members and associates in Associations, Organisations, Committees, Forums and Groups. (b) The members of the Associations, Organisations, Committees, Forums and Groups of the Trust shall not have any membership fees, but the person can become a member if they can deposit donation to the Trust.



The donation can be in cash or in kind form. The donations received from such persons who want to become a member of support Associations, support Organisations, support Committees, support Forums, support Groups of the Trust can not be refunded in any case if the Trust may cancel their membership from such forum, support groups, support organisations, support committees and/or the member does not want to be member of support groups/ forums/ associations/ committees.

The funds provided by such persons shall be for the charitable objectives of the Trust, so the person can work as a supporter of the Trust but not as a member (Trustee) of the Trust.

(c) The Board of Trustees or Authorised body or Authorised Trustee/ Member can authorise the Associations, Organisations, Committees, Networks, Forums and Groups formed by the Trust and under the Trust, to execute certain limited power and limited rights including tenure of membership and type of membership to/in/for such Associations, Organisations, Councils, Committees, Networks, Forums and Groups formed by the Trust and under the Trust.

(d) Appointed Members of the Associations, Committees, Forums and Groups can not have equal rights and status as of the Trustees of the Trust.

Appointed Members of the Associations, Committees, Forums and Groups can get certain rights as defined/decided by Board of Trustees.

(e) In all matters related to the Associations, Organisations, Councils, Committees, Networks, Forums and Groups formed; and other matters; the decisions of the Board of Trust of the Trust shall be final and can not be challenged at any level, as the Associations, Organisations, Councils, Committees, Networks, Forums and Groups and their appointed/selected members will be members, associates and affiliates by accepting the terms and conditions to become appointed/selected member, associated and affiliated with any of the committees or sub committees of the Trust in any decided form or pattern.

24. It is declared and understood that the Trustees shall have power to frame rules and/or bye-laws and also alter, vary, amend, delete the rules and/or bye-laws for the conduct and management of the Trust or the Trust Fund for carrying out the objects of the Trust and such rules and/or bye-laws, framed, amended, altered, varied deleted or substituted shall have the same force as if they have been incorporated in the original Trust hereby created but not repugnant to objects of the Trust, provided that no amendment shall be made without the prior approval of the Commissioner of Income Tax/Director of Income Tax (Exemptions) or any other department or/and authorities appointed and authorised by Government of India.

25. The Board of Trustees may from time to time form/frame/approve rules, regulations, procedures, policies, guidelines and by-laws of the Trust to manage, control, regulate, operate and implement the Trust's existing/amended/restated objects, programmes, affairs, activities, decisions and requirements.

26. The Board of Trustees may from time to time frame rules for the conduct and regulations of the meetings of Trustees. In the absence of such regulations:

(a) To form a quorum for Meeting of the Trust, more than half (majority) of numbers of the total strength of Board of Trustees are required. In case the more than half (majority) of numbers of the total strength of Board of Trustees are not present, then Two Trustees shall form a quorum for a meeting of the Board of Trustees.

(b) All proceedings, questions and matters arising at the meetings of the Board of Trustees shall be decided mutually or by the majority of votes; and in case of the equality or difference of opinion the Chairperson shall have a casting vote.

(c) Resolution passed without any meeting of the Board of Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the Trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Board of Trustees dually called and convened.



(d) A Trustee who is unable to be present may send his/her views on the agenda on the day of meeting or within 7 days after adjournment of the meeting, in writing and such expression of opinion shall be taken to be vote on the matter concerned.

(e) The minutes of the proceeding of every meeting of Board of Trustees shall be entered in a book kept for that purposes and signed by the Chairperson of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meetings.

(f) Notice of regular and special meetings of the Board of Trustees and its committees may be given to the Trustees at their addresses.

27. All meetings of the Trust shall be held at such place and at such time as the Chairperson of the Trust shall decide from time to time.

28. The beneficiaries of the Trust shall be public in general, irrespective of caste, creed, religion and sex. The Board of Trustees shall decide the basis and criteria to select and recognise the specific beneficiaries according to the specific requirements of specific programmes and specific projects.

29. The Board of Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorise the Trustees to spend the income or corpus of the Trust for any purpose not authorised by these presents.

30. The Board of Trustee or the authorised body shall have the powers to sell, convert or otherwise release any of the Trust properties, invest the funds of the Trust in any form of investment or change/alter the form of investment when they are satisfied that such investment will yield a reasonable income or when it is deemed expedient or necessary for carrying out the objects of the Trust, provided that such investment shall be in accordance with the investment pattern prescribed according to the Income Tax Act 1961, The Finance Act or any required law or act of Government of India from time to time.

31. Amount available with the Trust shall be invested in accordance with the provisions of Section 11(5) read with section 13(1)(d) of the Income Tax Act, 1961 and/or other sections of Acts, rules, regulations and laws recognised and applicable by Government of India including Income Tax Act, 1961.

32. It is, hereby, made clear that the income or funds or property of the Trust shall be applied only for fulfilling the objectives of Trust and none of the Trustees or their relatives shall be entitled directly or indirectly to any portion of such income or funds by way of dividends, interest or in any manner whatsoever.

33. The Trust shall be irrevocable and the Trust funds shall be irrevocable for all times.

34. The income of the Trust shall be solely utilised towards the objectives of the trust and no portion of it shall be utilized for payment to the Trustees by way of profit or dividend etc.

35. In case of dissolution of the Trust, shall have following rules and regulations will be applicable: (a) In case of dissolution of the Trust, the Trust can be amalgamate with any other charitable Trust, society, association, or institution of similar objectives.

(b) In case of dissolution of the Trust the net assets, property and funds of the Trust shall be transferred to a Trust or Society or Non Profit Company having similar objectives of this Trust.

(c) If the Trust fails for any reason, and in the event of dissolution, winding up of the trust, the remaining assets as on the date of dissolution shall, under no circumstances be distributed among the Trustees, but the same shall be transferred to another charitable trust / society / Non Profit Company whose objects and objectives are similar to those of this Trust and which enjoys recognition or with recognition parameters under the sections 12A and 80G of the Income Tax Act, 1961.

- (d) The trustees of the Board of Trustees shall not register any Charitable Society under the Society Jurisdiction Act, with objectives of the trust wherein all assets or some of the assets or all the income or some of the income of the Trust may be transferred to such Society.
36. The beneficiaries of the Trust shall be public and society in general and section of poor and underprivileged peoples of society. There will be no specific individual beneficiary of the Trust and Trust works.
37. The working and operation areas of the Trust shall be all over India according to decided and applied rules and laws of Government of India for Trusts/ Societies/ NGOs/ Organisations.
38. Offices of the Trust to run, setup, establish, manage, operate and implement the objectives, programmes, projects, activities of the Trust:
- (i) Trust can open/manage/operate offices at everywhere to support its objects, programmes, projects and activities but the working area of the Trust shall be India only. The rules and laws of Government of India shall be applicable to manage and operate the offices and support the objects and programmes of Trust; and the Trust shall follow and work under the rules and laws.
- (ii) The offices of the Trust can be moved anywhere in India, if the Trustees so decides. The Trust may open and maintain additional offices in any state in India. Trust can open/ manage/ run/ operate offices in all the states and territories of India including Delhi, Uttar Pradesh, Haryana and/or at any such other state, place or places in India as the Trustees may decide from time to time.
39. The accounting year of the Trust shall be the financial year ending on 31st March every year.
40. The Trust shall not carry out any business activities in the nature of conduction of any business for the purpose of profit and such activities shall be conducted as per the stipulations laid down in the Section 11(4) and provision to section 80G(5)(1) of the Income Tax Act, 1961.
41. The income, fee, cess, any other financial or/and any other achieved resources must be utilised for fulfillment of the declared objects of Trust that are for general public utility and mentioned in the Section 3 of the memorandum of the Trust 'CopyPen Foundation'.
42. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly. No part of the Trust income or assets is transferable, or to be applied for any purpose other than charitable purpose.
43. That any part of income or any property of the Trust shall be used or applied directly or indirectly for the benefit of any person as referred in section 13 (1)(c) of the Income Tax Act, 1961 including the Author/ Founder/ Settler of the Trust, any Trustee of the Trust, any relative or member of family of any Trustee of the Trust or any relative or member of family of any Author/ Founder/ Settler of the Trust.
44. The provisions and rules of Income Tax of India shall be apply on the Trust with all the matters mentioned in the presents and bye-laws of the Trust and on any by-laws, rules and provisions for charity accepted or implemented in the Trust in future by the decision or amendment. The provisions, bye-laws and rules of the Trust or Indian Trust Act, 1961 of present time and future time shall be under the Income Tax Act 1961, The Finance Act or any required law or acts of Government of India.
45. The beneficiaries of the Trust shall be from the general public and a section of the public eligible for charitable purposes as per the applicable laws and the socio-economical parameters. The beneficiaries of the Trust shall not be any specific individuals or any others restricted under the Income Tax act and any other applicable laws for charity or charitable causes.
46. The Trust can apply and receive the all kind of certificates under Income Tax Act 1961, The Finance Act or any required law or act of Government of India for exemption for Tax on the income and expenditure of the Trust and exemption for the grants, financial and other aid, support, funding and objects donated and provided by donors, supporters and help providers.

The Trust can apply to get the approval, certification and registration under section 10(23C)(vi), 12AA, 80G and 80GGA of Income Tax Act, 1961 and other required and/or applicable sections of Income Tax Act, 1961 for exemption of income by following the parameters, criteria and applicable laws of Income tax and other concerned laws of Government of India.

47. The Trust shall work only for the charitable purpose and all the object of the trust shall be charitable purpose. The Trust shall work according to all the sections, presents, acts, laws and bye-laws of Indian Income Tax Act.


The Trust shall work and undertake programmes, activities and projects according to the acts and laws of Government of India for charitable purpose and advancement of objects of general public utility.

48. The Trust shall work only for charitable purpose and all the object of the trust shall be charitable purpose. The Trust shall work according to all the sections, presents, acts, laws and bye-laws of Indian Income Tax Act 1961, The Finance Act or any applicable law or act of Government of India. The Trust shall work and undertake programmes, activities and projects according to the acts and laws of Government of India for charitable purpose and advancement of objects of general public utility.


49. The provision of Indian Trust Act 1882 shall apply to only those matters not specifically mentioned in these presents. Furthermore, if the Board of Trustees makes by-laws, rules and provision then the provisions of the above mentioned Act shall not contravene and override the consecutive provisions of the Trust.


